Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **0.72** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:

- Undertaking to pay Addl. NPV is not given.
- General abstract of trees, poles and plant not provided.
- The muck point is located at a short distance between two sections of the road which may cause damage to the lower section of the road. Hence another suitable muck point to be identified and KML to be resubmitted.
- Detail Muck Disposal Plan with Engineering and biological measures need to be submitted.
- Administrative and technical approval to be granted to the CA estimate.
- Area statement given in B-2.4 in Part-I is contrary to the area statement in the lay-out of the plan. Correction to be made

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
