महोदय,

विषयान्तर्गत संदर्भित पत्र से प्राप्त प्रस्ताव का परीक्षण उपरान्त निम्नांकित बिन्दुओं पर सूचनाएँ/स्पष्टीकरण दिया जाना अपेक्षित है:-

1. DCF Bhilwara (0.8676 ha.)
 - a) Crop density of the forest is incorrect. NPV rates to be taken as per density of the forest and latest guideline dated 6.1.2022.
 - b) As the project falls under soil and moisture conservation working circle, vulnerability of the soil has not been defined.
 - c) Details of wildlife has not been given.
 - d) Non Forest Land given in the project then why separate CA scheme is uploaded.
 - e) As per DCF certificate, no tree will be felled but details of tree shown 3 trees.
 - f) Copy of notification of forest land has not been submitted.
2. DCF Bundi (3.5593 ha.)
 - a) As per site inspection report, the part of the proposed area falls under buffer of Ramgarh Vishdhari Tiger Reserve. Details filled in the point no 8 of part II is incorrect.
 - b) Total 304 tree coming in the proposal, felling of these trees are required or not clarify.
3. DCF RVTR Bundi (0.5706 ha.)
 - a) Working plan/ Management plan prescription has not been submitted along with vulnerability of the area prone to soil erosion.
 - b) NPV is applicable in the proposal, hence certificate of NPV calculation is required.
 - c) Estimate of CA is not as scheme provided. 1000 plants per to be planted at the site. The proposed site is not suitable for 1000 plants due to presence of vegetation.
 - d) Status of 25 trees, whether they are to be felled or not. Clarify it.
 - e) Copy of notification of forest land has not been submitted.
4. User Agency
 - a) Area calculation sheet as per area falling in the sanctuary area has not been submitted.
