**Diversion of 15.94 ha of forest land in favour of HPPWD for the construction of Mud road Kms 0/000 to 28/430 ,within the jurisdiction of WL Division Spiti Distt Lahaul & Spiti, HP.**

**The following points are to be attended:**

1. Against column No.B-2.3,village-wise breakup has although been given. But as per GoI instructions dated 01.08.2019,a certificate (providing detail of villages) duly authenticated by competent revenue authority may also be submitted and uploaded in online part-I, as an essential document with the proposal on the prescribed format as under:

2. Although against column No.C(iv), digital map of the proposed road has been uploaded but has not been signed by DFO concerned. As per latest instructions of GoI, the map duly signed by the user agency and DFO concerned is required to be uploaded against this column.

There is difference in employment likely to be generated, mentioned against column No.E in online part-I and given in hard copy of the proposal. Against column No.E(ii), '1' and against E(iii), '50400', has been mentioned whereas in hard copy of part-I against column No.1(vi), 'The roads are constructed by A class contractors' has been mentioned. The employment details given in online part-I and placed in hard copy should match. Necessary corrections are required to be made in the employment details in hard copy of the proposal. In this regard it is clarified that employment whether it is temporary or permanent is required to be mentioned against the column in hard copy.

4. At the time of submission of the proposal online, the user agency has undertaken that the FRA certificate will be submitted after obtaining from the DC concerned. Still the undertaking has been uploaded against column No.K(i), whereas in the hard copy of the proposal, the complete FRA certificate has been placed but in all the folders, the copy of FRA certificate attested by the issuing department has been placed. As per GoI instructions, FRA certificate in original alongwith attested copies of all the proceedings duly attested by the issuing department are required to be uploaded/submitted.

5. Dumping has also been proposed over the forest land hence the muck management plan is also required to be uploaded against additional information detail in online part-I. Further cost estimate of plantation part of reclaiming the dumping sites has not been found placed in the proposal folder.

6. Penal CA has also been proposed in the present proposal. Hence KML file of penal CA alongwith digital maps of Penal CA are also required to be uploaded against appropriate columns.

7. Only two folders are required by this office whereas four folders have been submitted to this office. Two folders are returned herewith.
