**विषय: Diversion of 0.56 ha of forest land in favour of Bhup Raj, 162/9 Bhojnagar Bazar Sundernagar, for the construction of Dhanwan Small HEP (1.00 MW), within the jurisdiction of Jogindernagar Forest Division, District Mandi, Himachal Pradesh. (Online Proposal No. FP/HP/HYD/39107/2019).**

महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए आपको यह सूचित करना है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी हैं। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि आगामी कार्यवाही सुनिश्चित की जा सके :-

1. Layout Plan has been provided, however same is not complete as none of the components of the proposed project have been shown in the Layout Plan. Therefore, the complete Layout Plan showing all the components as mentioned in KML file with distinct colours duly authenticated by the concerned DFO is required to be submitted and the same shall be uploaded on the web portal as well.
2. NOC from fishery department is required.
3. In KML file 6 dumping sites have been mentioned whereas in Muck Management Plan only four dumping sites were mentioned. Clarification regarding the same may be provided.
4. Undertaking may be provided that in future no forest land will be proposed for construction of access approach from Dhangyan to Power house.
5. Copy of permission to HPPWD under FRA, as mentioned in point no 4 of State Government letter, may be provided.
6. A list mentioning total number of small HEPs in upstream/downstream of the landscape with their status (proposed /commissioned/ under construction) and other details like capacity, distance from nearest ESZ and/or PAs as applicable, may be provided. Further impact of these HEPs on the hydrology and ecosystem of the landscape and action plan to mitigate the anticipated adverse impacts may also be provided.

7. As per the DSS analysis, the proposed project site is within the boundary of Nargu WLS, however, the document provided by the State Government mentions that the aerial distance of the project site from the Nargu WLS is 5 km. Therefore, the State Government may review and re-verify the same and the exact aerial distance of the proposed project from notified ESZ of Nargu WLS may be provided/uploaded.
8. The TEC and IA may be provided/uploaded.
9. As per Evacuation arrangement and other documents provided, the total length of the proposed transmission line is 2.96 km with width of 7m. However, area mentioned for transmission line component is 0.26 ha only. There is clearly mismatch in the area provided for transmission line component. Therefore, the same may be reviewed and rectified accordingly.
10. It may be ensured in further communication that, the subject mentioned in the State Government letter is correctly written.
