महोदय,

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:–

- 1. As per DSS analysis of CA area it is found that KML file of 3.20 ha is found uploaded in place of 3.85 ha, out of which 2.00 ha area is falling in MDF proposed in civil and soyam land. State Government may upload KML file of 3.85 ha and submit the plantation scheme in lieu of area falling in MDF.
- 2. Working plan details area incomplete and incorrect at para 5 of Part II. State Government may provide correct information in this regard.
- 3. Details filled at para 7, Part II regarding found incorrect. State Government may provide the correct information against para 7, Part II i.e. "Approximate distance of the proposed site for diversion from boundary of forest (in km.)".
- 4. It is seen that DFO has not made any comment against para 5.3 in Site Inspection Report. State Government may submit the Site Inspection Report after ensuring that the comments against each para have been made.
- 5. One road is seen constructed towards southern side of the target village which could have been extended upto the target village to avoid forest land in general and 1773 ha of RF land in particular. State Government may submit detailed justification in this regard.

- 6. The note containing justification for locating the project in forest land uploaded at para-D, Part I is not satisfactory. State Government may submit revised justification in details.
- 7. Alternate alignment uploaded at para D (ii), Part I is not justified. State Government may explore the alternate alignment in view of point No. 5 above.
- 8. Name of Gram Panchayat is mentioned as Mujoli in the Village Level Committee (VLC) meeting proceedings of Malayangaon and same is also signed by Gram Pradhan of Mujholi Gram Panchayat instead of Gram Pradhan of Malayangaon. State Government may clarify this and submit the correct documents.
- 9. Geo-referenced digital map of CA area uploaded at para L and 13 of Part I & II respectively not authenticated by DFO. State Govt. may submit/ upload the original copy of digital map of the area proposed for CA duly authenticated by DFO.
- 10. For calculation of quantity of muck likely to be generated, the width of road is taken as 3.00 m instead of 6.00 m which has resulted into underestimation of muck. State Government may submit the correct and complete muck disposal plan taking the width of road as 6.00 m.
