 - (f) Production during last three years of each of such mine.
- 2. In the earlier proposal vide letter dated 12-10-2005 the state govt, informed that the distance of the present area is 10 km from Daran Ghati Wild life Sanctuary and 8.5 Km from Rupi Bhasa Wild life Sanctuary while in recent document of DFO it is more than 15 Km away from nearest sanctuary appear contradictory. Therefore, State Govt, may submit the CWLW certificate in this matter.
- 3. State Govt, may submit the Fresh NOC of village 'Pashada'.
- 4. State Govt, may submit the FRA certificate with all annexure in the prescribed format for non-linear projects.
- 5 State Govt, submit the copy of certificate approval issued by Govt, of H.P. Industry Department for establishment of stone crusher is required which is valid for the period of time for which approval is asked
- State Govt, may submit the certificate duly authenticated by the DFO that the rest of the land other than proposed for establishing stone crusher & approach road is beard with forest department.
- 7. The State Govt, may clarify that the project attract provisions of ElA notification 2006 if yes the details regarding status of EC may also provide in this office.
