With reference to the above, I am directed to say that under Point No.19. **Violation and Action Taken thereof**, you have stated that as reported by the DFO, Bonai Division, in Part-II & Site Inspection report, the user agency has worked inside the PRF area over 0.5951 ha without prior approval of Govt. of India, MoEF&CC and further an area of 0.078 ha of DLC forest land has been broken within the safety zone area and 0.214 ha of forest land has also been broken outside the mining lease area contiguous to the said safety zone in DLC area which are violation under the Van (Sarankshan Evam Samvardhan) Adhiniyam, 1980. But the period/(s) of violations and action taken thereof has not been intimated.

Therefore, you are requested to intimate the period/(s) of violations and action taken thereof to this Department immediately.
