महोदय,

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी हैं। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. राज्य सरकार से अनुरोध है कि उनके द्वारा Mini Stadium के निर्माण हेतु Standard design की प्रति उपलब्ध कराई जाये क्योंकि 'Open ground for Sports activities' हेतु 4.60 हे० क्षेत्र प्रस्तावित किया गया है जो कि अत्यधिक प्रतीत होता है।
2. प्रस्तावित क्षेत्र के समीप ही पर्याप्त मात्रा में open ground उपलब्ध है। उसमें भी Mini Stadium का निर्माण किया जा सकता है। राज्य सरकार इस संबंध में विस्तृत टीप प्रस्तुत करें।
3. The proposal is for non site specific activity and entire area falls in reserve forest area with enumeration of 356 trees involved in the proposal. State Govt. is requested to select some other land other than reserve forest and having less no. of trees for the purpose.
4. It is seen that habitation exists at three side of proposed area. DFO may verify whether any kind of encroachment is there?
5. Details of alternate not provided at para D in Part-I. The detail and comments of State Govt. are requested to be furnished as per guideline in this regard which is as follows:

“Diversion of forest land for non-site-specific projects: A number of proposals for diversion of forest land for non-site-specific projects like industries, construction of residential colonies, institutes, disposal of fly ash, rehabilitation of displaced persons, etc. are received by the Central Government. Attention is drawn to items 1(iv) and 8 of the Form 'A' in which the proposal is to be submitted by the State Government. In these columns, justification for locating the project in the forest area giving details of the alternatives examined and reasons for their rejection has to be furnished. Normally, there should not be any justification for locating non-site-specific projects on forest

land. Therefore, the State Government should scrutinize the alternatives in more details and must give complete justification establishing its inescapability for locating the project in forest area.”

6. Sub Division Level Committee (SDLC) meeting proceedings of Nainital and Haldwani found uploaded but complete area marked in Haldwani forest division as per part II. State Government may clarify.
7. FRA certificate of DM is dated 10.08.2016 however SDLC meeting of Haldwani held on 11.06.2019. State Govt. may clarify this and provide the correct information/ document.
8. As per DSS analysis, 8 ha area found in MDF. DFO may inspect the area and submit Site Inspection Report or a certificate mentioning if 1000 trees per hectare can be accommodated or not. If not, then the plantation scheme as per guidelines dt. 08.11.2017 may be submitted. DFO may also submit the feasibility of plantation in proposed steep slope of CA area.
9. As per details at para 8 (ii), proposed land is part of Shivalik Elephant Reserve. DFO may verify whether any approval applied or taken from CWLW/ NBWL.
10. Details of 356 trees uploaded in part II para 4 wherein 171 trees shown between 0 to 30 cm however details of 356 trees shown in tree enumeration list wherein no tree falls in 0 to 30 cm. Details of other class also do not match. State Government may clarify this discrepancy and submit correct information in this regard.
11. CA site suitability certificate and aerial distance certificate not found uploaded, which is required to be submitted/ uploaded.
12. Land schedule not countersigned by DFO. State Government may submit/ upload the land schedule duly countersigned by the concerned DFO.
13. Area mentioned in DFO's SIR is 3.90 ha. Further comments against para 5.3 not submitted. State Government may submit the SIR of DFO mentioning the correct area and providing comments against para 5.3 of SIR.
14. DFO has not submitted his comment in SIR as the area falls in Shivalik Elephant Reserve. DFO may also provide his comments in the SIR.
