With reference to the subject cited above in the aforesaid proposal the compliance on observations raised by this office vide letter dated 26/07/2019 is received vide your office file number Ft. 48-3290/2016 (FCA) dated 12/03/2020 for the approval under the provisions of section 2 (ii) of Forest (Conservation) Act, 1980. The reply on observations is examined and following shortcomings are still remained in the proposal is required to be attended by the State Government:

- 1. With reference to point number-5 of this office EDS dated 26/07/2019 the reply furnished by the State Govt. is not satisfactory as the area proposed for diversion for the component 'road' is equal to the area already broken under the violation of FCA, 1980 i.e.1.05 hectare. Further the State Govt. has reported that there are no tree felling involve on the area proposed for muck dumping i.e. 0.16 hectare. It means the whole enumeration is of the area proposed for the construction of road, which is already been broken. The clarification in this regard is required that whereas the area is already broken with the whole length (1854 mtr) and width of the road then how's this much of enumeration (93 trees & 39 saplings) comes out.
- 2. The certificated also needed from the DFO certifying that no plantation has ever been done earlier in the area that has been selected for CA in this proposal.
