The undersigned had inspected the proposed area for diversion of 1.27 ha mentioned in the subject and observed violation in Pudur Reserve Forest both by Vindhya Tele links and Reliance Jio as reported by the then DFO of Nellore and also reiterated by the DFO Tirupati of the violation occurred. In light of the above it was directed by the Ministry in the abovementioned Reference to take action against the violators under Section 3A/3B of The Van Sanrakshan Evam Samvardhan Adhiniyam, 1980. Site Inspection Report

Site Inspection of the proposal, FP/AP/OFC/38865/2019, Diversion of 1.27 ha. of forest land in Nellore, Venkatagiri, Udayagiri, Kavali and Atmakur ranges of Nellore Division(Tirupati Division after reorganization) for laying Optical Fiber Cable along the road within Right of Way (RoW) in favor of M/s. Reliance JIO Info comm Ltd., Visakhapatnam for providing 4G communication in the State of Andhra Pradesh - Forest Clearance under Forest (Conservation) Act, 1980, was done by the undersigned on 02.02.2024 along with Sri Sateesh, DFO Tirupati, Sri Gnana Prakash Rao, Sub DFO Venkatagiri and the Range staff and representatives of Reliance Jio Infocomm Ltd., where in the State Government had reported violation by the User Agency to an extent of 2006 running meters in Pudur Reserve Forest.

The following information was provided by the Forest Department Officials:

A. The violation of FCA came to light when on 27/03/2020 the Deputy Range officer Naidupeta detected that the trench was dug in Puduru RF along with Forest Beat Officer Chillamanur and Forest Beat Officer Naidupeta.

- B. When the issue came to light, on 27.03.2020, the Deputy range officer, Naidupeta registered a case vide UDOR No 32/19-20 in POR No. 2/33. On enquiry it came to light that the Cable was laid way back in 2018 by Vindhya Tele links Pvt Ltd and the department is of the opinion that both Reliance Jio and Airtel had committed the violation. During site inspection of Puduru Reserve Forest, the trench was dug taking due care to find the existence of the OFC cables. It is clearly evident that Vindhya Tele links have laid the duct and OFC, whereas the Reliance Jio had laid out duct but not OFC.
- C. This proposal was applied online with application No. FP/AP/OFC/38865/2019 for diversion of 1.27 ha. of forest land in the then Nellore Division, now Tirupati Division after bifurcation, in favour of M/s. Reliance Jio Infocomm Ltd., Visakhapatnam for laying Optical Fiber Cable (OFC) along the road within the existing Right of Way for providing 4G communication in the State of Andhra Pradesh as per the license granted.

From the inspection it is clear that the staff of the Range were not vigilant of the violation. It was concluded that the violation was done prior to March in 2018 but the case was registered only on 27th March, 2020. There was no information about the officer responsible for violation from the User Agency side. The forest Department officials mentioned that an area of 22 yards was excluded from the boundary of the Reserve Forest to the centre of the road in Yellasiri RF and the same area is not excluded in Pudur RF. Since the User Agencies, Vindhya tele links and Reliance Jio started digging the trench from Yellasiri RF and proceeded towards Pudur RF, since land is not excluded from the boundary of Reserve Forest to the edge of the road, violation had taken place in Pudur RF. After noticing the work in Pudur RF, the concerned Forest Range Officer has booked the case vide UDOR 32/2019-20, dated:27.03.2020 U/s 20(i), C(i) (iii) and (vi) of A.P. Forest Act, 1967. OFC cable was laid to a length of 2006 meters in a trench 0.5 m. depth and 0.5 m width which works out the quantity of 501.5 cu. earth work excavation was done and as per offense FSR, it's value was arrived at Rs. 2,64,290/-. Further, the work has been stopped since then and no further work has been carried out by the User agency after submitting proposals for diversion. Action will be taken against the concerned user agency as per the AP Forest Act, 1967. Therefore, no violation was done by the user agency after submitting the proposals for diversion U/S2 of Forest (Conservation) Act, 1980. The User Agency Reliance Jio Infocomm Ltd., had not deposited the amount as a penalty.

Action initiated on forest department officials:

- As reported, the District Forest Officer Nellore had issued notices to the user agency in Rc.no.999/2019/H5, dt: 03.08.2021 for violation of Forest Conservation Act, 1980. Subsequently the work was stopped. Further, explanations memos were issued to the concerned field staff for violation of F(C) Act, 1980 m Rc.no.999/2019/H5, dated:03.08.2021.
- There has been no reply from the staff for the memo served to them by the Divisional Forest Officer.

Submission made by the User Agency during the site inspection:

The representatives of the User Agency have submitted that the, violation is not done by them but by Vindhya Tele links Pvt Ltd. The UA agreed to abide by the decision of Forest Department for the above incident as per Rules and Regulations of Forest (Conservation) Act, 1980.



Recommendation:

As the User Agency carried out works in violation of FCA, 1980 over an extent of area under violation as reported in the proposal, it is not concluded by the forest department, which User Agency had first dug the trench to lay the pipeline. The violated / worked out area is properly covered by soil and since time passed, vegetation has come up on the alignment of trench. The proposal may be considered under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and as per the recent guideline, the proposal may be forwarded to the Ministry for the directions of the Competent Authority.
