Ltd for the construction of Integrated Kashang HEP Stage-II & III(130MW) for some modification in the Project component construction of Silt Flushing Tunnel (SFT) within the jurisdiction of Kinnaur Forest Division, Distt. Kinnaur, Himachal Pradesh. (Online Proposal No FP/HP/HYD/49387/2020)

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत अनुपालना रिपोर्ट का ध्यानापूर्वक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गई है:--

- 1. In reference to observation no-7, the explored alternative sites have not been uploaded on KML file. Therefore, State Govt. may upload all the explored alternative sites on KML. Further, already Approved Alignment Plan along-with Evacuation Plan of proposal no. 9-HPC-366/09-CHA, dated 14.06.2011 of Integrated Kashang HEP Stage-II & III may also be marked on KML.
- 2. In reference to observation no-10, The CB ratio needs to be submitted in ratio forms.
- In reference to observation no-13, the name of the components written in Part-I, Para B-2.4 are
 mismatching with the components name mentioned in KML file. This may be reviewed and
 rectified.
- 4. In reference to observation no-20, State Govt submitted that IA is not required for the said project as it is a Govt. project. Therefore State Govt may provide the documentary proof of non-requirement of IA for Govt. project.
- 5. In reference to observation no-21, document showing capacity of approved Muck Dumping Sites, Muck dumped, balance capacity and amount of muck to be dumped in tabulated form which is duly authenticated by DFO concerned may be provided.
- 6. In reference to observation no.-22, Revenue records and Jamabandi of diversion area is required to be uploaded/submitted on the PARIVESH portal.
- 7. In reference to observation no-23, the Layout Plan of the approved/proposed has not been provided. Therefore, State Govt. may provide the Layout Plan of the approved proposal (Integrated Kashang HEP Stage-II & III) along-with proposed additional DA. Further, all the components (approved and proposed) may be marked with evacuation plan in the Layout Plan, SoI and Digital Map, KML in distinct colour scheme and same should be uploaded on PARIVESH Portal, duly authenticated by concerned DFO.
- 8. 27 numbers of ecologically important trees (Pinus geradiana, Cedrus deodara, Pinus wallichiana) are proposed for felling. Therefore, possibility of reducing the numbers of trees to

LC/ULB/01/1/1/5055 be affected may be explored or rationalisation to be done in the layout of the proposal to reduce green felling. Further, a list of trees which are required to be felled and retained (Not to be

/42921/2023 felled) may be provided.

9. Enumeration list of trees with khasra number details, which is duly authenticated by the concerned DFO, needs to be provided/uploaded on the PARIVESH portal Part-II.

10. The geographical area of the district Kinnaur mentioned in Part-II, Para14 needs to be rectified.

State Govt may upload all the requisite information/document in the appropriate column with proper name and Sr. No in desired column of part-I/II of PARIVESH Portal.
