**Sub: Diversion of 4.6147 ha of forest land in favour of HPPWD for the construction of Gani to Bhorani Nala road (Kms 0/00 to 7/200), within the jurisdiction of Nachan Forest Division, Distt. Mandi, H.P. (Online Proposal No. FP/HP/Road/41345/2019).**

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानापूर्वक अवलोकन करने के पश्चात निम्नलिखित कमियां पाई गई हैं:-

1. 02 polygons of 9.229 ha and 04 ha are uploaded in online web-portal for CA site. The polygon which is not fit for plantation is required to be deleted. The polygon having density less than 0.4 and having area double the diversion area may only be uploaded.
2. The revised Penal NPV and NPV calculation sheet as per MoEF & CC order dated 06.01.2022 may be provided.
3. Year of violation is not mentioned in Part-II, Para-11(i) (b). The same is required to be mentioned.
4. In Penal NPV calculation, 12 % interest for violation has been calculated from last 5 years. However, as per FCA guidelines, 12% interest will be calculated till the deposit is made. Therefore, 12 % interest calculation in Penal NPV calculation may be reviewed and revised may be submitted.
5. As per document provided by Nodal Officer (FCA), the aerial distance of proposed site from Shikari Devi WLS is 4.25 km, however as per DSS analysis, the aerial distance from WLS is 2.06 kms. Therefore, aerial distance of proposed site from Shikari Devi WLS may be re-verified and comments of PCCF (WL) may be submitted, if required.
6. Since the ESZ of Shikari Devi WLS has been finally notified by Govt. of India, therefore, exact aerial distance of proposed site from notified ESZ of Shikari Devi WLS may be submitted.
