I invite your attention to the references cited.

Online forest clearance proposal has been uploaded by the Divisional Engineer, Highways Department, Construction and Maintenance Division, Cuddalore under Section 2 of Forest (Conservation) Act, 1980 for temporary diversion of 0.091 ha of forest land in Thiruthuraiyur RF for reconstruction of minor bridge at km 6/4 of Pudupettai- Oraiur- Karumbur-Paithampady road across Malattar River in Cuddalore District.

The District Forest Officer, Cuddalore Division and Conservator of Forests, Villupuram Circle have forwarded the forest clearance proposal with the recommendation of the project through web portal.

In this regard following details may be furnished.

i) Whether the proposal is for alternate road for reconstruction of damaged bridge across Malattar River in Thiruthuraiyur RF or for reconstruction of damaged bridge.

ii) If the present proposal of diversion of forest land is for alternate road for reconstruction of bridge, then there will be no need of use for alternate road on completion of reconstruction work. In such a situation, lease required for a period of 25 years as recommended by the Conservator of Forests is not required.

iii) The District Forest Officer and Conservator of Forests have not reported the details of Right of way allowed for the existing road cum Bridge portion.

Above particulars may be furnished early.


