Sir,

I am directed to refer to your letter No.Van Bhumi-21/2016-1961/Va.Pa. dated 9.5.2017 and letter No.Van Bhumi-34/2016-1960/Va.Pa. dated 9.5.2017 (File No. FP/JH/ROAD/23802/2017) received in this office on 15.5.2017 on the above mentioned subject and to inform that two different forest diversion proposals have been forwarded to this office pertaining to the same Gua-Salai Road from Km 2.00 to 11.00 and from Km 11.00 to 29.00.

It is to mention here that as per para 2.2(iii) of Forest (Conservation) Act, 1980, "*the projects for roads and railway line construction will be processed in their entirety. Therefore, proposals in piecemeal should not be submitted. A note on the present and future requirement of forest land is required to be submitted along with the proposal.*"

Therefore, it is requested that a consolidated proposal of Gua-Salai Road from Km 2.00 to 29.00 along with the note regarding present and future requirement of forest land in the project in Jharkhand State may be submitted to this office. In this regard, the original proposals received in this office are hereby returned with this letter.
