Subject: **Diversion of 0.1077 hectare of forest land for the construction of Police Station State Vigilance and Ant Corruption Bureau Shimla District Shimla, H.P. in favour of Deputy Superintendent of Police, Vigilance Anti Corruption Zone Distt. Shimla, Himachal Pradesh.**

Please refer to your office Memo. 1030 dated 05.05.2022 on the subject cited above.

2 The proposal received vide your above referred communication is found incomplete. The following shortcomings have been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index as per complete checklist.

- UA 1. In the short narrative of the proposal mentioned against column No. A1. (iii), the area is still mentioned as 0.2852 hectare. The area of the proposal be corrected accordingly in short narrative in online Part-I.
- CA 2. There are three components in the proposal i.e. Building, Parking & Road. Therefore, all three components are required to be mentioned against column No. B 2.4 of online Part-I. Area of each component should be mentioned separately against each component.
- DFO 3. Against column No. 7(v) of the Part-II of the proposal folder, the legal status of the forest land proposed for diversion has been mentioned as U-206 Badhai whereas against column No. 2 of online Part-II, the legal status of the forest land proposed for diversion has been shown as UPF 206 Badhai.
- DFO 4. Density of vegetation has not been mentioned against column No. 7 (vi) of Part-II of the proposal folder whereas in online Part-II against column No. 4 (i), the density of vegetation has been mentioned as 0.15.
- DFO 5. The distance of the project site is only 6.5 KM from the Shimla Water Catchment (Wild life Sanctuary). Therefore, comments of CWLW should be uploaded in online Part-II against additional information detail as and when is received.
- DFO 6. Total financial outlay for compensatory afforestation should also be mentioned against column No. 13 (i) of online Part-II.
- DFO 7. Total financial outlay for compensatory afforestation has been mentioned as Rs. 49,802/- against column No. 10 (iv) of the Part-II of the proposal folder whereas CA scheme is for Rs. 58,517/-. Necessary correction be done in Part-II of the proposal folder accordingly.
- CAF 8. Title of the project should be mentioned in Part-III, Part-IV & Part-V of the proposal folder.
- UA 9. The detail of each component should also be mentioned against column No. 2 of the Part-I of the proposal folder as well as in checklist No. 7 please.
- CCF 10. Checklist placed in the proposal folder at P.No. 1 to 8 is not counter signed by CCF concerned.
- UA 11. Date has not been mentioned in Part-I of the proposal folder.
- UA 12. Checklist No. 8 and certificate regarding non-availability of non-forest land placed in the second copy of the proposal folder at P.No. 22 & 23 are not authenticated by competent authority.

- DFO 13. In the Site Inspection Report placed in the proposal folder at P.No. 32, column No. 5 (a) & (b) has not been marked. Therefore, it is, not clear that whether there is any violation or not.
- DFO 14. Brief on vulnerability of the forest area to erosion should also be mentioned against column No. 7 (viii) of the Part-II of the proposal folder as has been mentioned in online Part-II against column No. 6.




