Circular:

This office has issued the detailed guidelines vide this office circular dtd-10/3/2016 as mentioned under reference 2, to be followed by the Divisional Forest Officer/ Deputy Conservator of Forests while granting approval under FCA-1980 for underground laying of optical fiber cables, telephone lines, drinking water supply lines, electric lines, CNG/PNG Pipeline and Petroleum pipeline.

Government of Gujarat, Forests & Environment Department, Gandhinagar vide its circular No. FCA/1015/1013/15/SF-83/F, dtd. 03-05-2016 has issued directions to be followed regarding the disposal of pending cases prior to the issue of circular dtd 4/2/2016.

In view of above, the following instructions are to be followed while granting approval under FCA – 1980 for the above purposes.

- The guidelines for granting General Approval by Divisional Forests Officer / Deputy Conservator of Forests for underground laying of optical fiber Cables, telephone lines, drinking water, electric lines, CNG/PNG Pipeline and Petroleum pipeline issued vide this office circular no. FCA/1015/1013/15/SF-83/F, dtd. 04-02-2016 is to be followed while granting General Approval under FCA – 1980.
- 2. The Concerned Divisional Forest Officer / Deputy Conservator of Forests shall grant approval under FCA- 1980 for all the pending proposals at GoG level as per the list attached herewith. In this regard they should collect the pending proposals / files from this office at the earliest.
- 3. The Concerned Divisional Forest Officer / Deputy Conservator of Forests shall grant approval under FCA- 1980 for all the pending proposals lying with the divisions on or before date -4/2/2016.

- 4. All the Compensatory afforestation (Non- Forest land and/ or CA amount) already recovered from the user agencies shall remain in ownership and possession of Forest & Environment Department, Government of Gujarat.
- 5. No Compensatory afforestation shall be charged to fresh proposals submitted after date: 4/2/2016.

All other instruction contained in the circular vide under reference 2 remain as such. It is reiterated that the user agencies are required to apply online and seek green signal from Nodal Officer, followed by submission of relevant documents in hard form and online.
