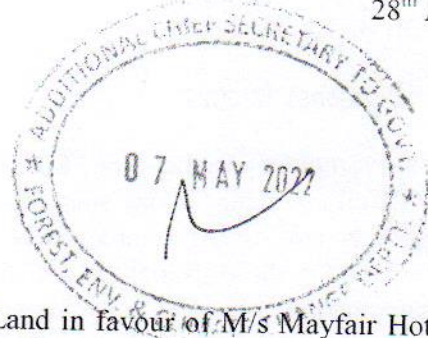

Sir,

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Forests (Conservation) Act, 1980. On scrutiny of the proposal, it was observed that the State Govt. has reported that the user agency has constructed building for Hotel over Revenue kism land without prior approval from Govt. of India, MoEF&CC in contravention of FC Act, 1980.

In the recommendation, it is not clear that whether this violation is attributable to the user agency or not. So that this case can be processed as pre the provision in Para 1.21 of Handbook of FC Act guidelines issued by Ministry vide letter dated 28.03.2019.

It is therefore requested to furnish the above desired information to this office for further necessary action.
