Renewal of 0.4087 ha of forest land for the extraction of slates in Mauza Kunar Tehsil Bharmour Chamba, in favour of Shri Prakash Chand S/o Shri Sorma Ram VPO Kunr, Tehsil Dharwala & Distt. Chamba, Himachal Pradesh (Online Proposal No. FP/HP/MIN/141848/2022).

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउतर का ध्यानापूर्वक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गई है:—

- 1. Forest Clearance was granted for 10 years w.e.f. 02.09.2010 and was co-terminus with Mining Lease period whichever is earlier. Therefore, accordingly Forest Clearance had been expired in 02.09.2020. Fresh Mining Plan was approved on dated 06.08.2021. However, renewal proposal was not submitted in time and there is delay of approximately 12 months. Therefore, State Government may justify in detail the delay.
- 2. Fresh Letter of Intent may be provided.
- 3. EC has been issued on April 2016 for 07 years and same has been expired. Therefore, fresh EC is required to be obtained.
- 4. In reply to observation no. 2, it has been informed that the District Survey Report showing this mining lease area has already been uploaded in online Part-I. However, same is not found uploaded.
- 5. In reply to observation no. 3, it has been informed that Reclamation Plan for the proposed mining area has been uploaded against additional information details in online Part-I. However, same is not found uploaded.
- 6. In reply to observation no. 6, Safety Zone has been included in Layout Plan and KML file in area outside the boundary of already diverted area (0.4087). Now, due to inclusion of safety zone in the outer periphery of Mining Lease area, total area has been increased from 0.4087 to 0.6241 ha. As per MoEF& CC directions dated 27.05.2015, Safety Zones shall be kept within the mining lease boundary and area of safety zone of a mining lease shall be a part of the total area of the mining lease. Therefore, same may be reviewed and revised accordingly.
- 7. Safety Zone component is also required to be mentioned in component wise break-up of Part-I.
- 8. In reply to observation no.7, it has been informed the records of all consultation and meeting of the Gram Sabha(s) and FRC(s) of the concerned village is uploaded at para K in online Part-I. However, same is not found uploaded.
