Madam,

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Forests (Conservation) Act, 1980. On scrutiny of the proposal, it was found that documents/information related to point No.(b) and (g) of MoEF&CC, Govt. of India letter No.8-34/2017-FC dated 20.05.2019 has not been provided. They are as below:

1. A certificate from District Collector to NTCA regarding non-availability of land suitable for relocation of the villages located within the Protected Area and Tiger Reserve before any proposal of relocation within the forest is approved.
2. Clarification on the extent of land de-reserved/de-notified for resettlement shall not be more than the extent vacated by the settlers in the core area.

It is therefore requested to kindly furnish the above information to this office this office for further necessary action.
