 - <u>Action Required</u>:- State Govt. may fill the correct data regarding employment generation at para E Part I.
- 4- At para A-3 (xvii) Part I, authorization letter found is not in the name as provided at para A-3 (i), (ii) & (iii) Part I online.
 - <u>Action Required</u>:- State Government may remove this discrepancy and submit and upload the authority letter on the person authorized to make application.
- 5- Justification for locating the Project in forest land is not c/s by DFO.

 Action Required: State Government may submit the justification duly c/s by DFO.
- 6- In Joint Inspection Report (JIR) area proposed for diversion is written as 3.92 ha and trees proposed to be felled in project is given as 777.
 - <u>Action Required</u>:- State Government may submit and upload correct JIR after removing the discrepancy.

7- Number of trees uploaded online at para 4 Part II are 275, however list of 442 trees including 311 Baanj trees submitted in the hard copy.

Action Required: State Government may correct the discrepancy and submit list of trees again duly c/s by DFO.
