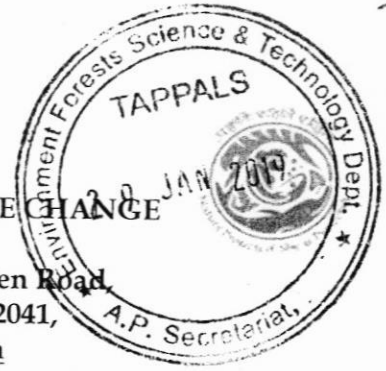

Please refer to the subject and reference cited above. I am directed to request you to furnish the following additional information / documents at the earliest for further consideration of the proposal;

- As reported, the User Agency has carried out work in violation of FCA, 1980 over an area of 8.08 ha in Chittoor East (WL) division. Hence a report on the action taken on the individual/officials responsible for violation under the provisions of the State Forest Acts / Rules, shall be furnished;
- As per the kml file uploaded by the User Agency for an area of 11.52 ha in Nellore Forest Division, it appears that work in violation of FCA, 1980 has been carried out by the User Agency in some patches within the 11.52 ha area. The State Government is requested to verify the same and submit a detailed report on violation i.e. extent of the area under violation, period in which work has been carried out, action taken on the individual / officials responsible for violation for violation under the provisions of the State Forest Acts / Rules;
