विषयः धार एवं अलीराजपुर जिले में छोटा उदयपुर-धार नई ब्रॉडगेज रेलवे लाईन के निर्माण हेतु 244.039 हेक टेयर (6.654 हे. अलीराजपुर वनमण्डल एवं 237.385 हे. धार वनमण्डल) वनभूमि उप मुख्य अभियंता (निर्माण-॥) पश्चिम रेलवे बड़ोदरा को उपयोग पर देने बाबत ।

संदर्भः नोडल अधिकारी, मध्यप्रदेश का पत्र क्रमांक एफ-5/1259/2023/10-11/1712 दिनांक 27/04/2023. महोदय.

उपरोक्त विषयक एवं संदर्भित पत्रों के संदर्भ में अधोहस्ताक्षरी को यह सूचित करने का निर्देश हुआ है कि प्रस्ताव से संबंधित अन्य वांछित जानकारियाँ/स्पष्टीकरण की आवश्यकता है। अतः निम्नतिखित जानकारियाँ/ दस्तावेज प्रेषित करने का कष्ट करें:-

- 1. Full KML file of layout plan of forest area and non forest area (full project KML file) shall be submitted/uploaded.
- 2. It is a new railway line project, so alternative alignment with comparative statement shall be submitted.
- 3. KML file for alternative alignment shall be submitted/uploaded.
- 4. Detailed muck calculation and muck disposal scheme as approved by concerned DFO shall be submitted.
- 5. Justification for location of the project in forest land (counter signed by DFO) shall be submitted/uploaded.
- No objection certificates of concerned department (Road, WRD, TL, etc) shall be submitted.
- 7. The submitted Cost-Benefit analysis is not for this proposal and not as per revised NPV rates. So, revised Cost-Benefit analysis shall be submitted.
- 8. Component wise breakup of land required and component wise area calculation with the layout plan shall be submitted.
- Administrative approval/ sanction letter from competent authority of the project shall be submitted.
- 10. As per the covering letter of proposal, the UA violated the rules and constructed the line in 4.50 ha of forest area (about 695 m) in Alirajpur Forest Division. Regarding Action Taken Report shall be submitted.

- The proposed diversion area is 05 (five) meter away from Lalgarh Fort and 500 meter away from Ganga Mahadev temple. Regarding NOC from competent authority shall be submitted.
- 12. As per SIR of Dhar DFO, some dependent persons are involved in proposed diversion area. Regarding rehabilitation plan shall be submitted.
- 13. The permanent employment generation is zero and temporary men days are only 1500. It shall be clarified.
- 14. Complete CA schemes & Maps alongwith a patch of 12.00 ha of Dhar Division shall be uploaded.
- 15. The KML area for CA of Dhar division does not matched with their CA scheme. So, the KML files shall be uploaded in accordance to CA schemes.
- 16. KML file of CA area for Alirajpur forest division shall be uploaded on web portal.
- 17. As per DSS analysis, the CA area of Sardarpur PF-459 is overlapping with another proposal of CA area (FP/MP/TRANS/156656/2022, Area 6.45 ha). The DFOs shall recheck all CA areas & rectified the same and also submit a certificate that CA areas are not overlapping with another CA.
- 18. As per DSS analysis, CA areas have 38.32 ha agriculture encroachment and 6.39 ha has previous plantation impression. It shall be clarified.
