Sub: Proposal for diversion of 9.423 ha of forest land for construction of 132 KV Link Transmission Line for evacuation of power from 400/132 KV Sub-station at Thoubal to 132 KV Sub-Station at Kakching and Chandel on existing 132 KV line from Kongba to Kakching on turkey basis in favour of Manipur State Power Company Limited, Imphal.

With reference to the subject and letter cited above, I am directed to inform that the proposal submitted has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The submitted proposal is found lacking of the following information:

- (i) The area of the submitted soft copy of the shape file is not matching with the proposed area for diversion i.e. 9.423 ha. State Govt to provide the correct soft copy of the shape /kml file of the proposed area.
- (ii) The soft copy of the shape/kml file of the proposed compensatory afforestation area.
- (iii)The GPS coordinates of the starting and end point of the transmission line passing through the forest area.
- (iv) The right of way of the proposed transmission line.
- (v) The 3D diagrammatic sketch of the proposed transmission line showing the nos. of the tower and the Right of Way.
- (vi)The Compartment No. of the proposed diversion site.
- (vii) Photographs and GPS co-ordinates of the site inspection of the proposed CA sites conducted by the concerned DFO/CF.
- (viii) The undertaking certificate by the user agency for the payment of the Addl. NPV.
- (ix) The hard and soft copy of Shape/kml files of the proposed diversion area and compensatory.

State Govt is requested to kindly furnish the above information to this office at the earliest for further processing of this proposal.
