With regard to the proposal submitted by this office vide Ref (1) seeking Stage-I approval under the Forest (Conservation) Act, 1980 to the Government of Karnataka and by the State Government vide Ref (2) letter dated 02-03-2022 to the Central Government, the Government of India vide Ref (3) letter dated 31-03-2022 has raised the EDS Query (enclosed) in which it stated that the aforementioned proposal was considered in 59<sup>th</sup> Regional Empowered Committee (REC) Meeting held on 22<sup>nd</sup> March, 2022. The Committee after detailed deliberation noted the following.

- Alternative examined are not provided.
- Feasibility of laying of pipeline on elevated structure may be explored so as to minimize the felling of trees.
- Location of break pressure tank is proposed in deep inside the forest area. Possibility of relocating the same at the initial point as done previously by other User Agencies, may be examined. If at all it is not possible to locate at the initial


- point then the same may be proposed in non-forest area / periphery of the forest area.
- iv. Whether the validity of the consent given by the Water Resources Department vide order dated 09-11-2015 for drawl of water from Tungabhadra reservoir has been renewed as per the condition no. 24 of the said order. If so copy of the renewal document may be furnished.
  - v. CA scheme is given only for 4 years and the same has to be revised for 10 years as per the FC guidelines.
  - vi. FRA compliance certificate furnished along with the proposal is not in proper format as per the FC guidelines.
  - vii. Discrepancies in the uploaded KML file of the proposed area to be resolved.

In view of the above, the REC has decided to seek information on the above points.

Hence, you are directed to communicate to the above points to User Agency through concerned jurisdictional Deputy Conservator of Forests regarding to furnishing the needful documents sought by the Government of India at earliest to this office for further processing of the proposal.

FC web portal link is hereby transferred for further transmission to Deputy Conservator of Forests, Koppal Division.

[Note: The CA scheme needs to be revised and all the documents need to be thoroughly checked by the concerned DCF, and submitted.]


