Sir,

With reference to the subject and letter cited above, I am to inform that the additional information submitted by the State Govt letter dated 17.05.2022 has been examined in this office. Moreover, the State Govt in its letter dated 24.11.2021 has mentioned that the guideline 3.B of MoEF & CC shall be imposed and proposing penalty of 20% NPV as per 3B.

It may however be mentioned that action under 3B requires action under 3 B (iii) i.e. taking action against officials concerned for not being able to prevent use of forest land for non-forestry purpose without Govt of India prior approval.

In view of the above, the State Govt is requested to submit the action on 3.B (iii) along with the chronology of events on the violation taken place, to this office at the earliest so as to enable this office for taking further necessary action.
