Sub: - Proposal for Diversion of 25.981 ha. of Reserved Forest land includes 2.460 ha. of Safety Zone in Toda RF for Mining of Iron Ore in ML-139 (A&B) under Bonai Forest Division. By SAIL in 1st RML.

Sir,

On scrutiny of the above diversion proposal, the following deficiencies are noticed.

1. Check list duly filled in should be enclosed to the Diversion Proposal.
2. The Lease Profile as prescribed in Para-2.1 (2) of the guidelines issued under the F.C. Act'1980 should be enclosed to the diversion proposal. The correct position of all Mining Leases of SAIL should be stated. (Page-230/DP).
3. Item No.A (iii) ^{of Part-I} has not been properly filled in.
4. In Item No.B-J of Part-I, it has been stated that the Project area is not located in a Scheduled area. This may please be re-checked and correct position stated.
5. In Item No.4 of Part-I, it has to be categorically mentioned whether E.C. has been obtained. In case E.C. has not been obtained, then copy of the application filed by the Lessee for issue of EC and received by the SPCB / MoEF is to be enclosed to the diversion proposal.
6. Reclamation should be taken up simultaneously with excavation of minerals. Accordingly, a concurrent reclamation scheme should be prepared preferably by a Mining Engineer or, a Geologist, and the Scheme should also be signed by him.
7. Phased Reclamation Plan (Plate-9) should contain the calendar of works to be taken up, and it should be authenticated by the DDM, Koira.
8. Authenticated DGPS Map should be enclosed to each copy of the Diversion Proposal.

You are requested to comply with the deficiencies and re-submit the Diversion Proposal within 7 days for taking further action at this end.
