Sir,

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Forests (Conservation) Act, 1980. On scrutiny of the proposal, it was observed that the State Govt. has reported that the user agency has constructed building for prayer hall without prior approval from Govt. of India, MoEF&CC in contravention of FC Act, 1980.

In the recommendation, it is not clear whether this violation is attributable or not to the user agency. If the violation is not attributable to the user agency then, this violation comes under which category as mentioned in Para 1.21 of Chapter-1 of Handbook of FC Act guidelines, may be clearly spelt out.
