Sir,

With reference to subject and letters cited above, I am to inform that the submitted action taken report by the State Govt letter under reference (i) above on the violation of the Forest Conservation Act, 1980 of this instant proposal has been examined in this office but found to be incomplete. State Govt is therefore requested to kindly furnish the detail action taken report including specific date and year of commencement of the work in this proposed area by the user agency without obtaining prior approval of the Central Government under the F(C)Act, 1980, the name of responsible person/staff/officer of the user agency for the act of violation of F(C) Act, 1980 along with the following information to this office for further processing of this proposal:-

- (i) To clarify the reason for uploading the proposed area in favour of CPWD despite the change of user agency to NHIDCL. The necessary correction in the proposal name in consultation with NIC, MoEF&CC, New Delhi is to be carried out on the Parivesh Portal.
- (ii) Whether the State Govt has initiated action against the responsible person/staff/officer of the forest department for dereliction of duty, if not the reason thereof.
- (iii) To clarify how the State Government was unaware of the road construction without obtaining the prior approval of the Central Government under the F(C)Act, 1980.
- (iv) The corrected shape/kml file of the identified CA area as the submitted file consist of three polygons of different areas.
- (v) The comments of the State Govt on the proposed road area i.e. 51.245 ha and muck dumping site Nos. 1 (0.365 ha), 2 (0.495 ha), 3 (0.495 ha), 16 (0.496 ha) & 18 (0.496 ha).

ha) are 'INVIOLATE' due to the presence of 'hydrological layer' and 'very dense forest', respectively as per the DSS report.

State Govt is requested to kindly furnish the above information to this office for further processing of this proposal.


