


Sir,

I am directed to refer to the Government of Sikkim online proposal no. FP/SK/ROAD/38739/2019, submitted in RO dated 18.03.2021 on the subject mentioned above, seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. The proposal forwarded by the State Government has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed there under. The State Government is requested to provide addition information for further processing of the case-

- 1. Soft copies of KML/ Shape file showing proposed area for diversion and Compensatory Afforestation area along with (boundaries) GPS coordinated.
- 2. SoI map showing proposal diversion area with GPS coordinated is to be submitted.
- 3. The proposed diversion area is near to river. Therefore, quantity of Muck to be generated with GPS coordinates of muck disposal area/Muck disposal plan and distance from river area is to be submitted.
- 4. Copy of certificate regarding initiation of FRA certificate is not uploaded.
- 5. The ROW and length of road is to be mentioned clearly.
- 6. The technically approved CA scheme and avenue plantation scheme for the road side plantation is not uploaded.
- 7. Cost cutting form is submitted at two different costs.
- 8. In cost cutting form, mentioned 97 nos. of pole and 50 nos. bamboo which is not clearly mentioned in site inspection report submitted by the DFO.
