On scrutiny of the proposal, it is noticed that, the user agency has not furnished RoFR Certificate as per Gol, MoEF Lr.No.11-9/1998-FC (pt) Dt.05.07.2013 in the prescribed format Annexure-I (Form-I) for linear projects duly certified by the District Collector for evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (RoFR) Act, 2006.

In this regard, the Chief Conservator of Forests /Conservator of Forests, Guntur is requested to obtain the RoFR Certificate from the user agency and submit the same to this office for further consideration of the proposal.

Further, the Chief Conservator of Forests /Conservator of Forests , Guntur should have verified the proposals thoroughly before forwarding such defective proposals to this office to avoid unwarranted delay in processing the proposals.


