विषय : Diversion of 9.3408 ha of forest land in favour of HPSEB Ltd. for the construction of Hail Hydro Electric Project (18.00 MW) HEP, within the jurisdiction of Churah Forest Division, Distt. Chamba, H.P.

महोदय,

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

- 1- The following components are need to be justified in terms of its purpose are: Job Facilities, Magazine, Valve house, Workshop & Store.
- 2- C/B analysis needs to be authenticated by DFO and rather than providing simple arithmetic values against all parameters in the table with suitable techno-economic tools based detailed analysis need to be submitted.
- 3- The CA as per guideline cannot be proposed over degraded forest land. The suitable area for CA may be submitted for equivalent non-forest land or any double degraded waste land which is not in possession of Forest Division in view of guideline para 2.4.
- 4- It is seen that in every case of Ravi catchment 2.5% or 1.5% of the project cost has been taken by the state govt. being value of comprehensive CAT Plan of Ravi Basin but the current status of its implementation providing details of area treated so far and fund utilised so far in respect to cases approved earlier by central govt has not been mentioned therefore the same may be submitted by the state govt.
- 5- The proposal involved forest as well as non-forest land, however forest land of area 1.5435 ha has been marked for muck dumping. The state govt. may review to find out ways to replace the forest area with non-forest area for muck dumping and provide separate enumeration details for area selected for muck dumping. The details in this regard need to be clarified by the DFO.
- 6- The revised allotment order may provided as the TEC is released for 18 MW while allotment order of dt. 6.04.2013 is for 14 MW.
- 7- State Govt. has informed that River Basin study for Ravi Basin is under process/consideration of MoEF&CC. Therefore, it may be clarified that whether any independent study is being carried out to assess the total potential of Ravi basin/catchment to generate power and how much already been harnessed or in line up?
