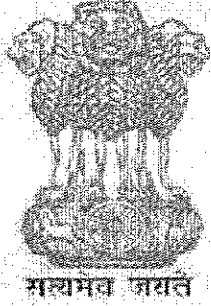

Sir,

Please refer to the subject and references cited above. In this regard, it is to inform that while processing the subject proposal, the Regional Office (RO) Nagpur sought certain additional information from the State Government through the PARIVESH portal, as mentioned in reference no. (1). The required information was subsequently received offline from the State Government vide the letter cited in reference no. (2).

However, upon examining the response received, RO Nagpur, vide reference no. (3), sought further information, for which a reply is still awaited.

Meanwhile, it has been observed by the Regional Office that the State Government uploaded its response (reference no. 2) on 18.02.2025 in the PARIVESH portal and resubmitted the proposal online.

In this context, based on review of the reply at reference no.2 and relevant rules in vogue, the State Government is requested to examine the proposal in accordance with the MoEF&CC notification No. S.O. 5074(E) dated 29th November 2023 and allied provisions, as it falls under the Left Wing Extremism (LWE)-affected districts.

Further, the examination of the KML file suggests the possibility of certain non-forest activities within the proposed diversion area. If a violation of the VSSA 1980 is confirmed, the State Government is requested to process the proposal as per the provisions of Para 17 of the MoEF&CC notification No. S.O. 5074(E) dated 29th November 2023.

In view of the above observations, the State Government is requested to re-examine the proposal in accordance with the relevant rules and do the needful.

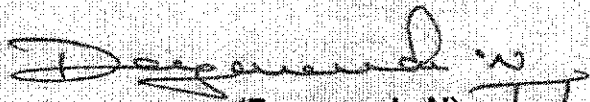
