Madam/Sir,

I am directed to refer to the Government of Himachal Pradesh's letter No.Ft.48-2883/2014 (FCA) dated 26.03.2022 forwarding additional information in response to this Ministry's letter dated 02.09.2021 and inform that the following shortcomings have been observed:

- (i) As per the DSS report the 4.00 hectare area proposed for road is overlapping with the area proposed for Dam site and Some solid structures are also visible in the proposed quarry sites. The State Govt may kindly verify the area/submitted KML files and submit a detailed report to this Ministry.
- (ii) Date of the enumeration of trees at FRL, FRL-2 and FRL-4 may be provided.
- (ii) No of village falling in the submergence area may be provided.
- (iii) The DSS analysis shows that the Pandoh, Dehra Power Plant Kol Dam, Suket Dam and any other nearby HEP who is falling in downstream of the proposed project (Copy of the GE map is attached for reference). Is there any study has been carried out by the State Government on what effect will it done on the above said project after construction the Thana Plaun HEP? The State may also provide the NOC from these DAM authorities.

(ii) The State Govt shall ensure that the R&R plan be prepared and submitted as per the latest provisions of law applicable in this regard.

(iii) The revised CA sites have been analysed on DSS and following is observed:

- I. Jogindernagar Forest Division
- a. KML file uploaded at S.no. 16 under column 13 of Part-II is not correct. (Range: Pangna, Comp. no.: Jamnu, Area: 117.8 ha)
- b. KML file uploaded at S.no. 11 under column 13 of Part-II is not correct. (Range: Kangoo, Comp. no.: Koon, Area: 5 ha)
- II. Mandi Forest Division
- a. KML file uploaded at S.no. 22 under column 13 of Part-II is corrupt/ not accessible. (Range: Sadar, Comp. no.: Sinhal, Area: 10 ha).
- (iv) The revised CA site have also been proposed in VDF and MDF as per details given below:
