Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. The kml file of diverted forest land has not been provided in CD. The uploaded kml file for diverted forest land shows multiple polygons and few are overlapping over each other which need correction.
2. The geo referenced map uploaded for proposed forest land diversion lacks geo coordinates of all key points.
3. (a) The land schedule showing calculation regarding requirement of forest land does not match with the uploaded kml files.
(b) The land schedule does not provide details regarding remaining right of way.
4. The linear strip plan of the proposal does not match with the shapes of polygons uploaded with the proposal.
5. The uploaded forestland gazette notification is not legible.
6. As per GIS DSS analysis the total area of Compensatory Afforestation site is 11.67 ha which is less than stipulated amount of compensatory afforestation as per provisions contained in Handbook of FCA 1980.
7. The compensatory afforestation estimate does not account for enhancement of cost due to inflation.
8. As per the kml files uploaded for compensatory afforestation, there are few patches where agriculture activity is visible. It would be pertinent to ascertain whether these patches are free from encumbrance/encroachment or not.
