Sub: Diversion of 12.04 ha of forest land for the construction of Bhanupali-Bilaspur-Beri (BG) Rail-Line (Phase-IV) in favour of Rail Vikas Nigam Ltd. within the jurisdiction of Bilaspur Forest Division, District Bilaspur, Himachal Pradesh. (Online Proposal No. FP/HP/RAIL/146861/2021).

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउतर का ध्यानापूर्वक अवलोकन करने के पश्चात निम्नलिखित कमियां पाई गई है:--

- 1. a) In Part 1, it has been mentioned 52.56 ha of land is involved where forest land and non-forest land is 12.04 ha and 40.52 ha, respectively. However, in the State Government letter dated 19-05-2022, at point no. 3, it was mentioned that 57.35 ha of area is involved in the project which includes the land area as mentioned above and other Government non-forest land 4.79 ha of HPPWD and State Electricity Board. This 4.79 ha of land shall be included in the non-forest area component in Part 1, wherever applicable.
 - **b)** All the revenue records and legal status (ownership) of non-forest land in 4.79 ha mentioned as above shall be uploaded.
- 2. a) The layout plan provided is not authenticated by the concerned DFO, therefore the authenticated copy of the layout shall be uploaded.
 - **b)** In the layout plan, the forest land and non-forest land involved shall be marked with distinct colours. The revised layout plan may be uploaded.
- **3. a)** FRA certificates, records and annexures of proceedings and consultations of FRC of 8 villages have been provided. However, records and annexures of consultations and proceedings of the Gram Sabha of all the 12 villages have not been provided. Therefore, FRA Certificate along with the records and annexures of consultations and proceedings of FRC and Gram Sabha of all the concerned villages including *Bhater Uparli*, *Jangal Brans*, *Khated* and *Barmana* villages are required to be uploaded before Stage-II.
 - b) In the proceedings of SDLC (No-BLS.SDM.FRC.2022-2183, Dated-28/03/2022) of the Bhater Uparli, Jangal Brans, Khated and Barmana villages it has been clearly mentioned that," Pradhan, Gram Panchayat, in reply to the notice has submitted that forest land and private land are adjacent, therefore there is ample confusion regarding the exact location of the forest land. The site of the state of

- *land in the above mentioned villages*". It is quite clear that ambiguity regarding the settlements of Forest Rights of the above mentioned villages has not been resolved yet. Therefore necessary clarification regarding the matter may be provided from appropriate authority.
 - 4. In the KML file the beneficiary villages (12 villages) are yet to be marked. Therefore, the KML file shall be revised, marking all beneficiary villages and components as mentioned in component wise breakup of Part 1, and the same must be uploaded on the web portal.
 - **5.** The Cost and Benefit Analysis provided is not according to the revised NPV rates. The same shall be revised accordingly as per revised rates and may be uploaded.
 - **6.** Muck Management Plan authenticated by the concerned DFO has been provided in hardcopy, however the same shall be uploaded on the portal as well.
