Sir,

With subject and reference cited above, I am directed to inform that the above proposal was discussed in the REC meeting held on 26.04.2024. The Committee observed that the proposed area comes under very dense forest. Further, the road is connecting two villages viz. Samapaju and Panisal. The proposed expansion of road is coming under only Phulbani Forest Division. The Committee desired to know whether any traffic study has been done for the instant road project? Whether strengthening of the existing road can be done without widening the RoW from 3.5 mtrs to 7 mtrs? The Committee deferred the proposal and desired to seek the above information from the State Govt.

It is therefore requested to furnish information on above observation of REC to this office for further processing of the proposal.
