## Diversion of 0.3705 ha of forest land in favour of M/S Micro Hydel Project 100 KW,310/3 Jail Road Mandi, HP, for the construction of Mohit Micro Hydel Project (100KW),in district Mandi within the jurisdiction of Mandi Forest Division distt Mandi, HP.

- Against column C(iii), although the toposheet has been uploaded but has not been signed by DFO concerned. As per latest instructions of Gol, the Copy of Survey of India Toposheet indicating boundary of forest land proposed to be diverted duly signed by the user agency and DFO concerned is required to be uploaded against this column.
- Against column C(iv) in online part-I, although the digital map of proposed project has, been uploaded, but has not bee signed by DFO concerned. As per latest instructions of GoI, against this column map of the proposed project duly signed by the user agency and DFO concerned is required to be uploaded.
- 3. Against column No.D(i), although the justification for locating the project over forest land duly signed by user agency has been uploaded but has not been countersigned by DFO concerned. Justification for locating the project over forest land duly signed by the user agency and countersigned by the DFO concerned is required to be uploaded.Similarly the map of alternate alignmenet has not been countersigned by the DFO concerned.
- 4. There is difference in the employment likely to be generated mentioned in online part-I and mentioned in hard copy of part-I. In online part-I, against column No.E(ii), '20' and against column No. E(iii), '27000', has been mentioned whereas in hard copy of part-I against column No.1(vi), '27000 mandays will be generated', has been mentioned. The employment likely to be generated mentioned in online part-I and mentioned in hard copy of part-I, should tally. Necessary corrections are required to be made in online part-I and hard copy of the proposal.
- 5. Against column No.K(i), although FRA certificate has been uploaded but is not on the format prescribed for linear project. Against column A-1(vi) shape of the forest land proposed to be diverted: linear has been mentioned whereas the FRA certificate has been obtained for the projects other than linear. Further, the FRA certificate and DC/ SDM level proceedings are photocopies. As per latest instructions of GoI, the original copy of FRA certificate alongwith attested copies of all the proceedings duly attested by the issuing department is required to be uploaded.
- 6. As per enumeration lists of trees, placed at P.Nos.42-43, in all 13 saplings of Kamal are standing over the forest land proposed for diversion and against column No.4(ii) of online part-II, 13 saplings have been mentioned between 0-30cm girth class which are required to be mentioned against remarks column and not against 0-30 cm girth class . Necessary correction is required to be made against this column. Further the enumeration list has not been signed by DFO concerned.
- 7. The site inspection uploaded on the portal and placed in the folder is not in order. In the site inspection report against column No.5(a), 'The user agency has not violated the provisions of Forest(Conservation) Act,1980 and no work has been started without proper sanction,' 'No' has been mentioned whereas as per online part-11' and hard copy of part-II, there is no violation of FCA.1980. Revised/corrected site inspection report of DFO is required to be uploaded/submitted.
