With reference to the subject and reference cited above, it is to inform that the subject proposal was considered by the REC, IRO Vijayawada in its 5th meeting held on 30.05.2022 and after detailed deliberation, the committee decided that "the State Government may consider the proposal and make validity of the approved FC coterminus with the mining lease period as per the Ministry guidelines with applicable conditions. In case any such situation arises not to make approved FC coterminus with the Mining lease, same shall be informed to the IRO Vijayawada so that renewal proposal can be processed timely and to process such renewal proposal, the User Agency shall submit approved mining plan through the State Government"
