Submission of diversion proposal for construction of Upper Udanti Irrigation Project under Forest Conservation Act, 1980.

Your Letter No.371 dt.29.03.2019.

Sir,

With reference to the above cited subject, you are requested to comply the following deficiencies and submit the same to this office at an early date for onwards transmission to the higher authorities.

1. You should submit the detail note on the project. It must include the information regarding the number of villages and number persons to be benefited from the project including employment generation.
2. It is seen that list of proposed land for diversion has been submitted by you but not in proper format. You should submit the details of forest area involve showing Survey No. /Coupe No./Compartment No. etc .
3. It is seen that land schedule of non forest areas involved in the proposal submitted by you are not in proper format. Hence you should submit the same alongwith the map of the said area duly attested by the revenue authority not below the rank of the Tahasildar.
4. You should submit the certificate from the project proponent that no alternative suitable non-forest land is available for the project in question, and that this is the best location from among several alternatives considered and involving the barest minimum extent of forest land.
5. You should submit the no objection certificate from the Gram Sabha.
6. FRA certificate in prescribed format issued by the Collector should be provided.
7. You should submit the species wise and girth class wise enumeration list and abstract of trees standing in the forest area.
8. It is seen that you have submitted a list of degraded forest land for C.A. But you hve not mentioned the Survey No./Compartment No. etc. alongwith the boundaries of adjoining area with their land use in distinct colours. You should submit the same for taking necessary action at this end.
9. You should submit the certificate from the D.F.O that non-forest land selected for compensatory afforestation is in a compact block and contiguous to forest area or in close proximity of forest area and suitable from the management and protection point of view.
