Sir,

The REC observed that State Govt. of Madhya Pradesh had submitted a proposal for diversion of 197.93 ha (Proposal No. FP/MP/OTHERS/696/2009) to MoEFCC, New Delhi. Looking to the KML file of both the proposal i.e. 16.268 ha & 197.93 ha on DSS / Google earth, REC noted that the present proposal (16.268 ha) of forest land is for the same purpose i.e. Industrial Development at Mandideep, MP and is contiguous and adjoining to the forest land i.e. 197.93 ha for MoEF&CC, New Delhi had issued Stage-I approval vide its letter dt. 20/12/2017.

Therefore, the REC **decided** that the State Govt be asked submit this proposal (16.268 ha) to MoEF&CC, New Delhi for clearance, as it is an extension of the proposal of 197.93 ha for which Stage-I approval has already been issued.
