Attention is invited to the subject and references cited above. Vide reference (1) cited above, that office raised some queries regarding laying of pipeline through vested forest in Kasaragode Forest Division. The gas pipeline from Kochi to Mangalore is scheduled to crossing a forest land is at the shortest distance only through the proposed forest site. It is not feasible to take the gas pipeline to circumvent the vested forest and implementing the project. Hence it is recommended to consider this proposal as the barest minimum forest land diversion and the only feasible laying of the LNG Pipeline.

Part III of the proforma duly filled by Chief Conservator of Forests (Northern Circle) Kannur and the undertaking submitted by User Agency was submitted herewith. 300 Mahagony saplings have to be removed for

implementation of this project. This project will benefit the public of both Kerala and Karnataka and hence the replies to the queries may be accepted.
