- 1. PF Notification of NFL provided for CA against the earlier diverted area has not been submitted in compliance to observation No.iii of PCCF (FD & NO,
- 2. The reasons for non-payment of NPV for the entire forest area within ML has not been furnished in compliance to observation No. v of the PCCF(FD & NO,FC Act).

In view of the above, the compliance submitted vide your memo under reference is returned herewith and further directed to submit the same duly complying the above observation to this office for further processing of the proposal.

With reference to the above cited memo Nos. on the captioned subject, it is to inform you that on scrutiny of the compliance report by the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer FC Act O/o the PCCF Odisha, Bhubaneswar, certain observations were noted vide his memo No. 7441 dt. 04.04.2024.

In response to the aforementioned observations, the user agency, i.e. G.M. Hingula Area, was duly notified to submit a point-wise compliance report along with all relevant supporting documents vide this office letter No. 2781 dt. 06.04.2024.

Now, the User Agency i.e. G.M. Hingula Area has submitted the point wise compliance report vide their Letter No. 440 dt. 08.04.2024. The details are given below.

In context of observation point No. (iii)

As per condition (ii) of the Forest Clearance vide L. No.8-143/89-FC dt.28.09.1990, the NFL land provided for CA must be transferred and mutated in the name of Forest Department and declared as PF before release of applied forest land being diverted through Forest Clearance.

In the meanwhile, 24 years have been elapsed but the allotted NFL for CA has only been mutated in the name of Forest Department. No attempt has been made to declare the transferred and mutated land as "PF". The same needs to be complied.

Reply by UA

In response to this observation, the UA, i.e., G.M. Hingula Area, has submitted an undertaking that 86.00 hectares of CA land identified against the diversion of 85.201 hectares of forest in Harpalli village in Kuarmunda Tahasil under Rourkela division will be notified as protected forest before Stage-II approval of the 193.845 ha forest land proposed for diversion for non-forest use. The undertaking is

In context of observation point No. (v)

Total ML area is 2574.0 ha. Out of which Forest Land is 278.0 ha and NFL is 2295.0 ha. It was stipulated to deposit NPV in the extant rate for the entire forest land of the ML. However, the UA has deposited Rs. 10,46,77,097/- only towards the NPV against the earlier Stage-II accorded forest land over 85.201 ha on dated 28.09.1990 in the extant rate. The User Agency has furnished an undertaking to pay the NPV of forest land within the mining lease. The reason of non-payment of NPV for the entire forest land within mining lease may be furnished.

Reply by UA

In response to this observation, the MoEF & CC noted in point No. (v) that proposal is for expansion of earlier approved area of 85.201 ha vide Ministry's letter dated 28.09.1990 (pg. 83-84/c). The State has provided the status of the reclaimed land. However, how much land out of 85.201 ha has been reclaimed it is not clear. Further, if the already diverted land has been de-coaled and reclaimed then why it of the UA then the State Government Shall ensure that NPV of per the Ministry's Guidelines dated 06.01.2022 read with the letter dated 22.03.2022.

Further, the UA, i.e., G.M. Hingula Area, clarified that 13.42 hectares of the total 85.201 hectares of forest land has been biologically 10,46,77,097/- only through UTR no. SBINR52024021502494266 dated 15.02.2024 for the earlier approved project of 85.201 hectares. The entire leasehold area. The demand letter may be issued to the user land for non-forest use. The undertaking is enclosed as Annexure-II.

In context of observation point No. (vi)

KML file of the proposed land use of forest land of ML has not been provided in the enclosed pen-drive. The same may kindly be provided.

Reply by UA

In response to this observation, the UA, i.e., G.M. Hingula Area, has submitted the KML file of the proposed land use of forest land of ML area in the pen drive.

Hence, the compliance reports along with pen drive received from the user agency i.e. G.M, Hingula area is enclosed herewith in four sets each for your kind information and necessary action.
