In inviting a reference to the subject cited above, I am directed to inform you that the Regional Empowered Committee (REC) in its meeting held on 5th March, 2020 had discussed this instant proposal for diversion 16.9806 ha (East Dist=11.858 ha + South Dist = 5.1226 ha) of forest land for laying of 220 KV Double Circuit Samardong to Dikchu Pool Transmission in East and South Districts of Sikkim. After detailed discussion and considering the justification and its importance on a large population of the region from the project, the REC approved the proposal, subject to submission of SoI toposheet map indicating the proposed area for diversion.

In view of the above, the State Govt is requested to submit the information as desired by the REC at the earliest so as to enable this office to take further necessary action.
