Please refer to the reply of EDS dated 17-3-2023 on the subject cited above.

2. From the perusal of the reply as submitted vide above referred EDS it reveals that the reply of the shortcomings are not being scrutinized properly. The following shortcomings have been noticed which may be attended in all respect:-

1. In reply to point No. 4, GoI has asked to provide the WLM Plan alongwith detail cost of its implementation, but neither any plan has been found uploaded nor any undertaking found.
2. In reply to point No. 5, GoI has asked to provide the Soil Moisture Plan alongwith detail cost of its implementation if applicable., but neither any plan or undertaking has been found uploaded nor any clarification regarding its applicability has been found uploaded.
3. In reply to point No. 6, the revised enumeration lists of trees stated to submitted vide your memo. dated 10-10-2022 whereas same is required to be uploaded online.
4. The reply of point No. 8 to 11 stated to have been submitted vide your memo. dated 10-10-2022 and from the perusal of said memo, requisite documents stated to have been uploaded whereas same is required to be uploaded online against appropriate column.
5. In reply to point No. 12, Digital map of CA stated to have been uploaded whereas, photocopy of KML file has been uploaded in Part-II
6. The revenue record still has not been found uploaded in Part-I online, the detail of uploaded documents i.e. Sr. No., column No. Part etc. be mentioned
7. The sale/gift deed has still has not been found uploaded in Part-I online, the detail of uploaded documents i.e. Sr. No., column No. Part etc. be mentioned Further, the project folder in PDF format is required to be submitted online.

You are, therefore, once again requested to ensure the proper scrutiny of each observation as raised by GoI and upload the requisite document online by mentioning the reference of uploaded document (i.e. Sr. No., column No. & Part) in forwarding memorandum. The reply should be submitted in the format circulated vide this office Memo. No. Steno/FCA/2023 dated 31/3/2023 alongwith softcopy of the reply.
