Sir,

With reference to the subject and letter cited above, I am to inform that the request of the State Govt for some more time to furnish the additional information in respect of this instant proposal which was sought by this office vide letter dated 20.12.2017 with Reminders dated 25.10.2018, 24.04.2019 and 04.03.2020 has been examined in this office. However, it is to be mentioned that this proposal was submitted by the State Govt vide letter dated 30.09.2016 and the proposal was discussed in the REC held on 11.12.2017 wherein the REC had observed certain observations which are to be furnished by the State Govt. It appears that the State Govt is taking a long time in submission of information when proposal is already four years running.

In view of the above, the State Govt is requested to send the EDS as appropriate or to decide a time frame of not more than 90 days for submission of the additional information, beyond which this office will be constrained to take action as per rules.
