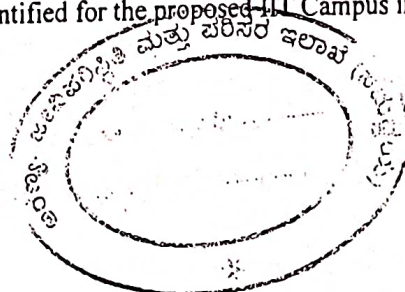

Sir,

I am directed to refer to Government of Karnataka letter No.FEE05FLL 2022 (e) dated 24.02.2022 on the subject mentioned above and to inform that on examination of the aforementioned proposal, it is noticed that certain portion of forest land proposed for diversion is part of already diverted area (to an extent of 27.72 ha) for construction of 220 KV DC Transmission Line from Hubballi- Belagavi-Narendra (Hubli 2<sup>nd</sup> Stage) in Dharwad District, for which this Ministry has accorded approval vide its letter No. 8- 16/99-FC dated 14th June, 2004. Therefore, use of this portion of forest land for another purpose needs to be treated as a case of re-diversion. Accordingly, it is requested to re-submit the proposal as per para 5.6 of Handbook of Forest (Conservation) Act, 1980.

Further, it is also requested to furnish the legible map depicting the boundary of the proposed IIT Campus *vis a vis* to boundary of reserved forest along with the legal status of land identified for the proposed IIT Campus in Dharwad.
