1. In Part-II online, density of vegetation is shown as '2' whereas no tree/plant to be felled is mentioned. However Google Earth imagery shows dense vegetation at proposed site.
2. Uploaded SOI toposheet for CA site is in grey scale and it is without No.
3. NOC from PWD B&R not uploaded.
4. Layout Plan approved by PWD B&R is also required to be uploaded.
5. In layout plan/KML file, approach road to plot has not been shown.
6. As per damage report uploaded under additional information of Part-II, user agency has violated of FCA, 1980, but in specific recommendation letter (Part-II) of DFO, NO violation has been shown which needs to be corrected.
7. NOC from DTP be uploaded.
8. Bhoj Plasra Khasra No. 175, Khatoni No. 12 Such site will have to be notified as Protected Forest as per guidelines.
9. CA Scheme to be provided with plantation operation breakup year wise.
