The Chief Conesrvator of Forests (T), Pune on 25/04/2022 has submitted proposal for diversion of 0.9971 ha. Reserved Forest land under section-2 of the Forest (Conservation) Act, 1980 for Construction of Mhaskewasti Irrigation Bungalow section of Village Road from Chainage Km 0/300 to Km 1/480 at Bharnewadi, Taluka Indapur, Dist. Pune in the State of Maharashtra. Following discrepancies has been observed in the said proposal -

- 1) The starting point and end point not shown in the KML file of land to be diverted.
- 2) Diverted Area KML file has showing forest compartment boundary but Compartment Number not given in KML file. The revised area statement is showing compartment no. to be submitted and same need to be rectified in KML file C.D.
- 3) The KML file dully highlighting the non forest area his properties
- 4) CA KML file has showing forest compartment boundary but compartment number not given in the KML file C.D.
- 5) Suitability certificate of C.A area along with details of site selection is not enclosed in the proposal.

The above discrepancies need to be compiled at the earliest.
