I am directed to request you to submit following information/clarification regarding above mentioned proposal for diversion: -

- 1) The SIR of DFO and Part -II submitted for the proposal for diversion is for **Protected forest land** and State Govt vide its letter dated 23/04/19 submit the proposal for diversion of **Revenue forest land**. Thus State Govt is requested to clarify the status of the land is Protected forest land or Revenue forest land.
- 2) Cost benefit analysis in prescribed format shall be submitted.
- 3) FRA certificate alongwith Gram Sabha resolution shall be submitted.
- 4) Certified copy of Statement regarding distance from the nearest protected area shall be submitted.
- 5) CA scheme for 10 years shall be submitted.
- 6) Analysis of proposed area map shows requirement of connectivity with main road to project site. Thus State Govt. is requested to clarify whether the proposal involves approach road or is the part of present proposal.

The above documents shall be submitted to this office and uploaded on e.portal in requisite column or as an additional information/documents column.
