Sub: Proposal for seeking prior approval of the Central Government under Section-2 (ii) of the Forest (Conservation) Act, 1980 for non-forestry use of 20.383 ha of forest land in favour of the Mahanadi Coalfields Ltd. for continuation of mining operation at Bhubaneswar OCP within Mining Lease area over 658.724 ha under Angul Forest Division in Angul District, Odisha- Compliance to GoI observations dated 04.07.2023 regarding – Revised CA Scheme regarding.

In inviting a reference to your memo cited above on the captioned subject, I am directed to request you to furnish the following documents relating to the revised CA scheme over 63.408 ha of Degraded Revenue Forest Land (DRFL) in village Karnapur under Talcher Tahasil of Talcher Range against diversion of forest land over 26.416 ha for Bhubaneswar OCP of M/s MCL:-

1. Land schedule of CA land duly signed by the User Agency, DFO & Tahasildar has not been submitted.
2. There is mismatch of CA land in DGPS map and the identified CA land.
3. Original SOI Toposheet map (1:50,000 scale) depicting CA land duly signed by the User Agency, DFO & Tahasildar has not been submitted.
4. KML file of CA land has not been furnished.
5. Allotment/ Alienation order of Degraded Revenue Forest Land for CA by the Collector concerned has not been furnished.
6. Non-encroachment/ Non-encumbrance certificate of Degraded Revenue Forest Land for CA duly signed by the Tahasildar concerned has not been furnished.
7. Certificate from DFO that no plantation has been carried out in the identified CA land in any scheme previously has not been furnished.
